The Shire has recently assigned a contractor to repair the cracks in the courts, however the job is unsatisfactory. The Shire's Manager of Infrastructure Services advised contractor is available on Thursday 26 May 2016 for repair at no additional cost.

Summary

For Council to consider Lake Grace town roads to be included in Restricted Access Vehicles network 2-4.

Background

Main Roads Western Australia (MRWA) has granted temporary access to roads in the Lake Grace townsite for Restricted Access Vehicles (RAV). A formal adoption by the Council is required to have these streets added to the RAV network.

Comment

MRWA advised the Shire of Lake Grace by email, dated 29 April 2016, that interim RAV access is approved for the following roads, subject to the following conditions:

- Bishop Street approved for RAV network 2-4 between Bennett Street and the depot driveway at the corner of Collie Lake King Road (road transport operator Darren Spencer requested the section of Bishop Street from his driveway to Collie Lake King Road to be included to the Network);
- Bennett Street approved for RAV network 2-4 between Bishop Street and Carruthers Street; and,
- Carruthers Street approved for RAV network 2-4 between Bennett Street and Collie Lake King Road with the condition of no left turn permitted into Collie Lake King Road from Carruthers Street (refer to attached).

<u>Summary</u>

To consider and endorse the write off of outstanding Emergency Services Levy (ESL) and Penalty Interest on A6037 and A6164 as they have been raised in error.

Background

A6037 – 21 Seward Avenue Varley is Unallocated Crown Land. It appears that levies have previously been raised on this property in 2002, and then written off in the same year. The current arrears charge was raised in 2012 with penalty interest levied in 2014 and 2015.

A6164 – 13 Sugg Road Lake King is Unallocated Crown Land. It appears that levies have previously been raised on this property prior to 2002, and then were recommenced in 2006 to 2015. With the exception of billing years 2014 and 2015 the charges have been reversed as raised in error. Correspondence had been received from the Department of Land Administration at the time to advise the land was not rateable.

Comment

On running the Final Notices to be sent out on the above properties were identified as having outstanding ESL charges. On investigation it was discovered that both properties were Unallocated Crown Land, and the land is not rateable.

Given the current Delegation, F08 only allows the Chief Executive Officer to write-off balances less than \$50.00 the item has been referred to Council.

As the charges have been levied in prior years, Council endorsement is required to write the balances off. If the error had been identified in the year they were raised administration would have been able to reverse the charges as they were in error.

 - (a) when adopting the annual budget, grant* a discount or other incentive for the early payment of any amount of money; or
 - (b) waive or grant concessions in relation to any amount of money; or
 - (c) write off any amount of money,

which is owed to the local government;

- * Absolute majority required.
- (2) Subsection (1)(a) and (b) do not apply to an amount of money owing in respect of rates and service charges:

- (3) The grant of a concession under subsection (1)(b) may be subject to any conditions determined by the local government; and,
- (4) Regulations may prescribe circumstances in which a local government is not to exercise a power under subsection (1) or regulate the exercise of that power.

<u>Summary</u>

For Council to consider a request from Lake Grace Recreation Committee for landscape works at the Sports Pavilion.

Background

At a recent site meeting with Mr John O'Neill, attended by the Shire Manager Infrastructure Services Louka Shopov, Mr O'Neill proposed landscaping works to be undertaken at Lake Grace Sports Pavilion, which were not included in the scope of the project completed in January 2016.

However, these works could be considered as part of the overall Recreation Precinct upgrade. Generally projects of this nature are funded on the basis of one third (1/3) Shire and the balance by way of a grant and community contribution.

The proposed landscaping and brick paving works include:

- 1. Removal of 100 millimetres deep layer of existing hard stand area between the main building and football oval (approximately 480 square metres) and replacement with sand and installation of lawn;
- 2. Excavation of 100 millimetres wide by 300 millimetres deep by 60 metre trench for future irrigation system;
- 3. Installation of 97 metre long concrete gardening kerb; and,
- 4. Installation of 30 square metres of brick paving at western side of the pavilion (refer attached Site Plan).

Comment

The project works are split between Shire of Lake Grace Construction Crew, Concrete Kerbing Contractor, and Brick Paving Contractor. The three parts of the projects are less than \$5,000.00 and require minimum of two (2) verbal quotes for each component. Quotes have been obtained from Nambec Nominees (0427 652 151) and Rylan Kerbing (0417 183 639) with additional quotes to be finalised.

Summary

The purpose of this report is for the Council to consider the attached Cemeteries Amendment Local Law 2016, for the Presiding Member to give notice of the purpose and effect of the proposed amendment local law and for approval to advertise seeking community comments on the proposed amendment local law.

Background

The Shire of Lake Grace Cemeteries Amendment Local Law 2015 was adopted by the Council on 18 November 2015 and was advertised in the Government Gazette on Tuesday 15 December 2015.

All local laws are subject to a review by the Joint Standing Committee on Delegate Legislation (JSCDL) and in a letter to Shire President Councillor Walker, dated the 25 February 2016, the Chair of the JSCDL Mr Peter Abetz MLA, advised that the JSCDL wished to raise two issues with the Council that required a further amendment to the Cemeteries Local Law.

The Council at its meeting on 23 March 2016 resolved in part as follows:

3. To prepare a draft amendment to the Cemeteries Local Law to rectify the errors identified by the Joint Standing Committee on Delegated Legislation. **MOTION CARRIED 9/0**

Comment

Section 3.12 of the Act outlines the procedure for making local laws which is broadly as follows:

- the person presiding is to give notice to the meeting of the purpose and effect of the proposed local law in the prescribed manner;
- the Shire is to give State-wide public notice stating:
 - the local government proposes to make a local law the purpose and effect of which is summarized in the notice;

- a copy of the proposed local law may be inspected or obtained at any place specified in the notice; and,
- submissions about the proposed local law may be made to the local government before a day to be specified in the notice, being a day that is not less than 6 weeks after the notice is given;
- give a copy of the proposed local law and a copy of the notice to the Minister and, if another Minister administers the legislation under which the local law is proposed to be made, to that other Minister;
- provide a copy of the proposed local law to any person requesting it;
- at the close of submissions consider any submissions made and take into consideration any comments provided;
- adopt the local law as originally published or as amended, subject to the amendments not substantially altering the intent of the local law;
- publish the local law in the Government Gazette;
- give a copy of the local law to the Minister and, if another Minister administers the legislation under which the local law is proposed to be made, to that other Minister;
- after the local law has been published in the Government Gazette the local government is to give local public notice:
 - o stating the title of the local law;
 - o summarising the purpose and effect of the local law (specifying the day on which it comes into operation); and,
 - o advising that copies of the local law may be inspected or obtained from the local government's office; and,
- within 10 days of the publication in the Government Gazette submit the local law to the Joint Standing Committee on Delegated Legislation.

S3.12(5) of the Act requires the Shire to give state-wide notice for a period of 42 days from the date of publication of the advertisement inviting submissions on the proposed local laws.

The purpose and effect of the proposed Cemeteries Amendment Local Law 2016 is outlined below:

Purpose: To amend the Shire of Lake Grace Local Laws Relating to the Lake Grace,

Newdegate, Lake King and Varley Public Cemeteries to correct errors in the adoption of the Shire of Lake Grace Cemeteries Amendment Local Law 2015.

Effect: To delete clause 1.2(3) and amend clause 6.1(1) of the Shire of Lake Grace

Local Laws Relating to the Lake Grace, Newdegate, Lake King and Varley Public Cemeteries to ensure an appropriate interpretation of the local law.
