# 3.0 PUBLIC QUESTION TIME

# 3.1 MR HUGH ROBERTS – LAKE KING

Mr Roberts asked the following series of questions and concerns regarding road works in the Lake King area, mainly in regard to the Norseman Road:

- 1. Main concerns regarding Norseman Road:
  - The width and state of the road on the bitumen section between the Lake King townsite crossroads and Kathleen Road.
  - On one part, between Kathleen Rd and Ladyman Rd, because of the width and roughness, two trucks cannot pass each other safely.
  - Between Ladyman Road and Hatters Hill Road potholes in road a patch has blown out, it has been marked three times and still has not been fixed.

- The section where the bitumen widening, reseal and re-sheeting was done is lifting only \$20,000 was spent and the job is very ordinary.
- Work is not being finished off properly patched up work on Norseman Rd east of Hatters Hill Rd which was blown out at harvest time is still not fixed properly.
- Email was sent by Jeanette De Landgrafft in March advising \$90,000 budgeted for Lake King Norseman Road.
- •We have been asking since 2005 for works to be done on the Lake King Norseman Rd, a letter was written to Councillors in 2008 and the matter was again brought to Council's attention at its meeting at Varley in March 2010 still nothing has been done.
- 2. Request copy of works budgeted for the Lake King area since 2005.
- 3. Hogan Rd re-sheeting which was done in April 2010 there is still 300 metres more to be done to finish this job properly why wasn't it done while the gear was there?
- 4. Mine trucks carting ore to Esperance the sub contractors are carting via Kathleen Rd, Pickernell Road and Mulcahy Rd shouldn't they be on Carstairs Rd?
- 5. Roads have not been patched properly over the past couple of years maintenance grading is good.
- 6. As a ratepayer he feels that the eastern end of the Shire is not getting its fair share of budgeted roadwork, most of it appears to be spent in the western end of the Shire.
- 7. Why are the rate notices out a month late?

The Shire President advised Mr Roberts that of some of the areas of attention that he has brought to Council's attention today – some have been passed on to staff. The Manager of Works is in attendance today and anything that is not responded to today will be put in writing.

The Manager of Works advised that:

- Works to Norseman were subject to budget allowances would be followed up
- Pot holes need to look at where and why
- Expenditure back to 2005 look at previous budgets
- Mine trucks we need to go back to mining company we have been assured they are using the designated roads
- Hogan & Pickernell Roads need to follow up

The Shire President commented that in the past few years it would maybe seem that this end of the Shire has had a rough deal due to other priorities which included the aftermath of the floods in Lake Grace. At this point in time Council is going with a 5 year strategic road plan, so don't be surprised if for a little while things don't happen while more needy things are caught up on. With \$3 million being expended on roads this year the Shire is doing its best.

# 10.1 CR ARMSTRONG

Cr Armstrong reported attendance, along with Cr Chappell at the Rural Water Council (RWC) Meeting held in Northam on 17 September 2010.

Main points of interest from the meeting:

- Covered a fair amount of in house advice with regard to where the RWC is going into the future.
- Due to demise of the Water Advisory Group the RWC is ramping up and looking for members.
- The Shire of Lake Grace is currently the most southern member, with the most northern member being the Shire of Moora.
- Shire of Moora voiced its major area of concern that of Water Corporation headworks costs on land developments means blocks will have to be sold for \$100,000 in order to recover headworks costs – not viable in rural areas. They feel local governments could do a lot of the work in cooperation with the Water Corporation for less cost.

Cr Armstrong believes it a most worthwhile group and suggests 2 delegates be appointed from the Shire of Lake Grace.

#### 10.2 CR MILTON

Cr Milton advised attendance at the CEO Review Meeting on 6 September, Audit Committee Meeting this morning and other community meetings.

Cr Milton wished to thank the Chief Executive Officer for his organisation of a fantastic visit to the City of Kalgoorlie Boulder this week.

#### 10.3 CR CHAMBERLAIN

Reported that he had chaired the Bushfire Advisory Committee Meeting last week and gave a brief outline of topics covered – Minutes will be available via the Information Bulletin.

Attended a Dry Season Meeting in Newdegate – there is a lot of stress in community – Centrelink welfare people were in attendance and were very helpful in encouraging all families to get family support. The Beyond Blue organisation supports the 15 to 25 year olds - support needs to be extended to the whole community.

Attended Lake Grace Development Association meeting and a Living Communities meeting which was well responded to by the Lake Grace business houses – a grant application has been submitted.

- The City hired a bus and we were taken on a tour which took in visits and meals and refreshments at:
  - ➤ Hammond Park a good central park facility that caters for all ages and groups
  - ➤ The new Graham Marsh designed golf course a magnificent facility, three golf clubs combined into one
  - ➤ The airport which is in pristine condition and very well run the Manager showed us their recently installed machinery for scanning explosives and other security initiatives

# Background

The three year contract for the Maintenance Grading - Lake King and Varley held by TW & PM Henderson which commenced on 1 September 2007, expired on 31 August 2010.

Council, at its 25 August 2010 Ordinary Meeting, authorised the Chief Executive Officer to call tenders for Maintenance Grading in the Lake King & Varley area. At that time it was reported that tenders would be evaluated by using the following selection criteria:

This was later found to be incorrect in that the Regional Price Preference no longer applies to tenders – Shire of Lake Grace Purchasing Policy 3.7, adopted in February 2010 allows only for Local Price Preferencing for purchases under the \$100,000 tender threshold.

The percentage weighted sub totals were the added to the price points totalling a score out of 200.

The Alternative tender, submitted by Timberden Plant Hire was based on a square metre rate, which when compared and weighted resulted in an excessive per kilometre cost.

Several tenderers have the required ability to carry out the contract including possessing suitable plant and equipment to perform the work with substantial experience in providing maintenance grading services, however TW & PM Henderson's work practices are proven.

Based on the above it is recommended that the tender from TW & PM Henderson be accepted.

Council, at its 25 August 2010 Ordinary Meeting, authorised the Chief Executive Officer to call tenders for Gravel Pushing & Stockpiling within the Shire of Lake Grace. At that time it was reported that tenders would be evaluated by using the following selection criteria:

This was later found to be incorrect in that the Regional Price Preference no longer applies to tenders – Shire of Lake Grace Purchasing Policy 3.7, adopted in February 2010 allows only for Local Price Preferencing for purchases under the \$100,000 tender threshold.

The new contract is for a three year period commencing Tuesday 5 October 2010 with the option of two (2), one (1) year extensions at the Shire's discretion.

Tenders were advertised in the 'West Australian' on Saturday 28 August 2010 and closed on Monday 13 September 2010 at 10.00am.

The following five (5) conforming tenders were received:

The percentage weighted sub totals were then added to the price points totalling a score out of 200.

Serveral tenderers have the required ability to carry out the contract including possessing suitable plant and equipment to perform the work with substantial experience in providing gravel pushing and stockpiling services, however Davmin Holdings Pty Ltd work practices are proven.

Based on the above, it is recommended that the tender submitted by Davmin Holdings Pty Ltd be accepted.

# Summary

The purpose of this report is to seek Council's approval for the Chief Executive Officer to proceed with Phases 1, 2 and 3 of the proposal by GHD for the Lake Grace Flood Mitigation Preliminary Design subject to the successful securing of external funding; and in the event that funding the project is successful:

- a) Phase 1 and Phase 2 proceed at a cost of \$113,493 (GST ex); and,
- b) Phase 3 proceed at a cost of \$50,000 (GST ex).

# **Background**

In February 2009, the then CEO presented two reports to Council that made comment that as a result of the January 2006 flooding of the Cemetery lake, damage to the townsite was substantial and the flooding of the main entrance road into Lake Grace a disaster for the community. It was also important that the community is well prepared and all steps are taken to minimise the risk for any such future event.

Accordingly, at the Ordinary Meeting of Council in February 2009, the then Council resolved the following:

#### **Motion 10743**

That the report: Lake Grace Urban Stormwater Investigation – December 2008 prepared by GHD Pty Ltd be adopted.

#### **Motion 10744**

Moved Cr Milton Seconded CR Farrelly

That the report titled Lake Grace Townsite Flood Study prepared by GHD Pty Ltd dated December 2008 be adopted by Council.

As such, the requirements to deal with the outcomes of the reports prepared by GHD have now been adopted within the Shire's Strategic Plan 2010 - 2015.

The author met with GHD consultants on 3 August 2010 to discuss the development of a proposal to implement the preferred outcomes of the GHD Report known as the Lake Grace Townsite Flood Study. The meeting was attended by Simon Cleary, Almos Blums and Robin Connolly. The key objective of the meeting was to establish whether there was a practical, cost effective preliminary engineering

solution that protects the Lake Grace townsite from flooding which is a direct result of flows upstream and in the vicinity of the known bottleneck at the corner of Stubbs Street and South Road in the design 100-year Average Recurrence Interval (ARI) flood event with a view to preparing construction documentation for the works.

Accordingly, the author discussed with the consultants the following:

- A review of the recommended Option 3 Flood Mitigation Concept;
- The need to undertake desktop study and site visit to ascertain site restriction and constraints, including land use planning, environmental and safety;
- Meet with key stakeholders to review of the proposed Concept with a view of gain provisional endorsement – Shire of Lake Grace to convene;
- Review & update the existing surface water model to determine the storm water flows in the area for a 1:100 year event;
- o Confirm the likely position, size and hydraulic profile of proposed infrastructure;
- Prepare preliminary drawings of proposed infrastructure (Long Sections, Cross Section etc);
- Develop preliminary cost estimate (+/- 30%) and preliminary construction schedule; and
- o Present recommended solution to stakeholders for comment.

A copy of the proposal by GHD is attached.

#### Comment

It is proposed by GHD to undertake the project as a series of work packages so that there is an opportunity to keep a close eye on the cost of the project as it proceeds. Each package or phase cannot commence until the previous one has been completed and evaluated including the cost and the Shire has given instruction for it to do so. The key phases of the project have been set at:

Phase 1 – Concept Refinement, Workshop and Endorsement

Phase 2 – Concept Design (15% Detailed Design)

Phase 3 – Additional investigation (ie Survey, Geotechnical Investigation,

**Environmental Constraints**)

Phase 4 - Detailed Design

Phase 5 – Approvals

Phase 6 - Tender and Procurement

Phase 7 - Construction

Costs to complete Phase 1–3 are included within GHD's proposal. The author has approached the Wheatbelt Development Commission for out of session funding for GHD to undertake the preliminary design encapsulated with Phase 1-3.

Accordingly, the timeline for the project is proposed as follows:

The timeline of the project fits in with the timeline within the Strategic Plan and the Corporate Plan.

# Comment

#### **Grain Freight Review**

The author and Manager of Works attended a workshop in Katanning on 31 August to consider the implications of moving the grain freight task through to the port zones and to develop an overall position or level playing field regarding heavy vehicle access on rural roads. This included taking into account:

- The role and commitment CBH plays in this process. CBH is now looking to move grain out over 4-5 months each year instead of 9-10 months. This means that there will be a significant increase in the dual demand for the use of rail and road at the same time. This will include the mapping of strategic pathways;
- The main roads or those under the State's jurisdiction taking the bulk of the freight task;
- The need for access to the quickest routes and the quality or increased capacity of these routes but not at the expense of local rate payers.

The Chair of the Great Southern Regional Road Group Cr Pech addressed the meeting and commented that local governments cannot keep doing what they have always done re open slather on the roads. The Minister for Transport is interested in what the Grain Freight Task Group is developing. Cr Stan McDonnell Chair of the Grain Freight Task Group discussed the need to put in place relevant categories including policies and permits, monitoring the road use and whether CBH will ever release its long term bin strategy. In otherwords Local Government will have an opportunity to set the scene and offer some direction regarding CBH and the State.

Main Roads confirmed that it has submitted a plan for the future to both the Minister and Cabinet. Main Roads representatives implored the group to look at the big picture. John Rossiter from Main Roads commented that by allowing bigger rigs on the local roads regarding paddock to bin, local government is undermining rail and putting pressure on shire roads. Others commented on the future of on farm storage and how that this will be 50% of all grain storage and as a result will change the grain task.

The group then reviewed the respective maps and identified those bins that required more direct access to a main road or rail. As a result Cardno will now produce a map for further consideration regarding those bins that need more direct access to main roads and rail.

#### Summary

The purpose of this report is to bring Council up to speed on the Teleconference held by the Australian Rural Road Group Inc (ARRG) on Monday 30 August 2010. In particular a report is being prepared in time for the National Road Congress in Bunbury where the ARRG will speak and launch its media campaign.

#### Background

At the March 2010 Ordinary Meeting of Council, it was resolved for the Shire to be a member of the Australian Rural Road Group Inc (AARG). The Shire President and author attended the inaugral meeting on 15 March 2010 and then the second meeting of this group at the Australian Local Government Association Congress on 14 June 2010.

The purpose of ARRG is to develop a strategy to lobby the Commonwealth Government for additional new road funding regarding those local governments throughout Australia where the value of their agricultural activity is in excess of \$100M. As such Lake Grace is ranked 25 overall with its agricultural activity coming in at \$192.8M and as such is the second most productive district in WA. Esperance sits at number two on the list overall with \$370.8M.

The premise is to tie an acceptable level of funding to the amount contributed to the Gross Domestic Product expressed as an amount per kilometre of the road network length.

# Comment

The author participated in the ARRG Teleconference on Monday 30 August 2010 with the Shire President an apology. The purpose of the meeting was to discuss the development of a report by Luke Fraser from Juturna Consulting in time for the National Roads Congress in Bunbury that looks at:

- Pulling all the work together so far;
- Economic modelling on a number of key issues:
  - Size of the group. The group represents 50% of all agriculture produced in Australia;
  - The population for the area underpinning this level of productivity is 1.5M:
  - o Contains 1/3 of the Local Government Road network throughout Australia.

Mr Fraser and the group discussed the development of a 20 year framework that will address long term road infrastructure planning. In other words the plan will support local governments throughout Australia get their strategic infrastructure right. This is reliant on relevant asset management plans. At this point in time the status of asset management planning in each state is:

Queensland: Well advanced

Victoria: Has 10 year plans in place

NSW: Compulsory to have plans in place within the next three

years

South Australia: Has identified the gap and well under way with planning

Western Australia: Knows the gap, but there are few plans in place

The discussion then focussed on the importance of doing the asset management process correctly so that the holes are found. At the same time it will be important to push for the provision of services that the State/Commonwealth are responsible for and plug the gaps due to reduced level of services so far. In essence the last round of Stimulus funding was out of step with the needs of Local Government i.e. human services infrastructure instead of road infrastructure and the like. We need to be united and Local Government is better placed to know where funds should be directed.

Discussion was also held on depreciation on roads versus the backlog of road works to maintain the road network. In short, as the years go by the level of depreciation decreases (the written down value of the roads), but the backlog increases.

The group also commented that the States need to put the same level of investment re asset management of state roads. It was also agreed to remove the peri-urban local governments from the model e.g. City of Wanneroo. The report will also include a section on safety issues and the need to legislate for misfeasance.

So the goal is to work towards a National picture where people can log in and review the plans regarding the ARRG or road network in general.

The ARRG has been granted time to speak at the National Road Congress in Bunbury and will also do the official launch of this group at the same time.

# Summary

The purpose of this report is to keep Council informed on the recruitment of a general practitioner (GP) for the Shire of Lake Grace.

#### Background

At the August Ordinary Meeting of Council, the author presented the different options regarding the attraction and retention of a GP. This included:

- An agreement with the Wheatbelt GP Network to recruit a GP and manage the practice;
- Setting up a group scheme with the Shires of Corrigin, Kulin, Kondinin and Lake Grace;
- A service provided by the Southern Regional Medical Group.

Since the August meeting the Shire President and the author attended a meeting on 30 August 2010 in Kulin with the presidents, CEOs and other representatives from the Shires of Corrigin, Kulin, Kondinin to discuss setting up or participating in a GP group scheme for at least the four shires. The discussion included:

- The need to set up a group scheme that is administered or at least the practices run by a separate body e.g. Wheatbelt GP Network;
- Recognition that the 457 Visa process needs changing to allow more overseas GPs in;
- Whether the shires could enter into an agreement with a third party to run the GP Group Scheme;
- The Group Scheme made sense because it provided the doctors in the scheme a system of respite;
- The Scheme would consist of at least three four doctors with a registrar;
- Agreement to work together initially to develop a framework for consideration:
- The CEOs would develop a statement for release confirming that the four shires were looking to work together to resolve their respective GP issues.

The author met with local Lake Grace resident Mrs Betty Daly King on 31 August 2010 to thank her for writing to a range of politicians and other stakeholders regarding the GP situation in Lake Grace. Also the Lake Grace Development Association has written to the Minister for Health. It is the author's understanding that the Health Department is preparing a ministerial response.

On Saturday 4 September the author received a phone call from the current locum at the Lake Grace Medical Centre. The doctor and author then had a meeting that afternoon and discussed how she could help Lake Grace as she was a former member of the Rural GP Board. The outcome was agreement for the doctor to speak on the Shire's behalf to GPs at the national rural GP conference next month and handout information regarding the shire and the medical facilities and support available. The author subsequently developed a new flyer for this purpose. The doctor also said she will approach leading GP magazines seeking them to do an article on the Shire and what is on offer.

On Monday 6 September, the author spoke with Gemini regarding the financials for the Lake Grace Medical Centre and the status of GPs that were available. The financials have now been provided and forwarded to Southern Regional Group for consideration.

With the status of GPs, Gemini advised that it had eight doctors that could be provided, but would not do so as the WA Country Health Service had written to this organisation and refusing to credential (provide them with admitting rights) to work in WA rural and remote hospitals until they had six months experience working under supervision in a hospital with an emergency department. As a result these doctors have been referred onto Tasmania.

The author immediately raised this issue with Belinda Bailey the CEO of Rural Health West and Tim Free the Regional Director Wheatbelt WA Country Health Service. Ms Bailey then contacted the Health Department for clarification. The response has been a willingness of Health Department personnel to touch base with Gemini to clarify and improve the relocation of GPs.

On 7 September, the Shire received a response from Independent Hon. Tony Windsor MP to the author's letter as mentioned at the August SMT information session and will use the matters raised in the letter when dealing with the Commonwealth Government in future including further appropriate representations.

At the Wheatbelt Infrastructure Forum in Northam on 8 September, the Minister for Regional Development and Lands in response to questions from Cr Patroni (Shire President – Yilgarn) on resolving the GP issue for rural and remote WA, the Minister commented that Local Government should not be involved in the provision of GP services as this lets the Commonwealth off the hook. Cr Patroni had discussed these issues with the President and author prior to the meeting.

Dr Tony Mylius the new Regional Medical Director Wheatbelt contacted the author on 9 September to respond to the email sent to Tim Free. Dr Mylius commented that there is some flexibility regarding the credentialing process and would assist the shire(s) achieve an appropriate outcome.

The author has also received expressions of interests from several overseas doctors and these have been referred to Rural Health West for assessment. A generic letter has been received from a doctor that has settled in Tasmania. The author has spoken to this doctor and sent her further information.

Belinda Bailey and Rural Health West Staff met with the Shire CEOs and Presidents from Corrigin and Lake Grace on Tuesday 14 September to work up a viable model for the four shires.

The outcome of the meeting was agreement for Rural Health West to develop a group scheme model for consideration. This model will be based on health, social, demographic and financial data for the four shires. It will also take into account the current status of health provision in rural WA including the fact that the area covered by the four shires forms part of a corridor that is considered the most isolated in Australia for solo GP's.

#### Comment

Gemini's comments tend to indicate that it is receiving genuine interest from overseas trained doctors. Also Gemini's Ms Pearce made it very clear that if the eight doctors had been credentialed by the WA Country Health Services then the Shire of Lake Grace (and others) would have a permanent doctor once more. As can be seen in the background information this has caused a flurry of activity and found WA Country Health Service to have a renewed willingness to assist resolve the placement of GPs in rural and remote hospitals.

One of the uncertainties in setting up the group scheme is the impact that the Local Government Act and its regulations have on what arrangements local governments can enter into. However, this comes down to finding a suitable vehicle to set this arrangement up and the four shires feeling comfortable with this. Options include:

- Setting up a formal regional council. Not desirable in the first instance as
  this will put in a place a dedicated local government for this purpose. It will
  then be administered by separate staff or by staff from the representative
  shires that act in addition to the work they currently perform. So this ads a
  level of cost and red tape that defeats the purpose of what the shires are
  trying to do but may be the only way forward at the end of the day;
- Individual partnerships between each of the group scheme shires and the Wheatbelt GP Network or other body. Implies that there is a voluntary ROC in place and that the formal part of running the group scheme is left to the Wheatbelt GP Network. Of course in a sense of irony this may be Gemini;
- Local Government Trading entity once the legislation is established to allow local governments to set up commercial entities. This is some way off but may be the final solution.

Once the proposal has been received from the Southern Regional Medical Group or others and the model from Rural Health West that includes consideration of the group scheme it may be appropriate for Council to hold a special meeting to make a decision on the management of the Lake Grace practice.

### **Summary**

For Council to endorse an application to the Community Sport and Recreation Facilities Fund (CSRFF) on behalf of the Newdegate Country Club Inc. to replace the grass greens of the Newdegate Bowling Club with synthetic turf.

# Background

Applications to CSRFF must be received at the Regional Office of the Department of Sport & Recreation by 29 October 2010. Successful applications will be notified in February/March 2011.

A Department of Sport & Recreation CSRFF requirement is that Local Governments prioritise and endorse CSRFF applications within their district for each funding round.

The project was prioritised and supported in an application to the 2009/2010 CSRFF funding round however that application was unsuccessful. Department of Sport & Recreation staff gave the following feedback on the application:

- The fund was heavily oversubscribed.
- Within the Shire of Lake Grace there are two existing synthetic bowling greens.
- Given the low membership level of the club [29], the CSRFF committee prioritised other applications ahead of Newdegate although having merit (reducing the workload of volunteers and the financial impact of ongoing costs including water) it was not deemed a priority.

Newdegate Bowling Club has attained quotes for an alternative synthetic surface, and consulted Terry Waldron, MLA, Minister for Sport and Recreation, Racing and Gaming, and Department of Sport & Recreation staff.

# Comment

Newdegate Country Club has received a quote for the installation of synthetic turf (Tiger Turf - Super Green II) costed at \$202,200. The Club

estimate an additional \$20,000 is required to build new shelters, install paving and concrete the edges. The project total including in-kind contributions, accommodation and a 4% contingency allowance is \$246, 374.

Funding (\$71,088) for the project is being sought through CSRFF, \$120,000 contributed by Newdegate Country Club and the Newdegate community with the remaining \$37,800 cash plus excavation of green quoted at \$9,200 contributed by the Shire of Lake Grace. The Newdegate Bowling Club is willing to contribute a cash component of \$60,000 and volunteer labour to assist in completing the proposed project.

Should Council be requested to part fund the Newdegate Bowling Green project then the project has implications for specified area rates. The Shire of Lake Grace's contribution to the project would be covered through Council's Specified Area Rating (SAR) programme for the Newdegate area. In accordance with Council Policy 3.3 Specified Area Rates, a community survey is not required as the amount requested is less than \$50,000

The Newdegate Country Club facility benefits members of the Newdegate Bowling and Golf Clubs, and members and players from sporting clubs throughout the region, particularly those geographically closer.

Newdegate Bowling Club estimates its current water use to be 1400-1800 kilolitres per year. The Club estimates, by installing the synthetic turf, water savings will be approximately 75% at 1050-1500 kilolitres per year. Additional savings in energy use, maintenance, chemicals and wages are expected. The cost of grass green maintenance at the existing facility is estimated at \$13,640 per annum.

The Shire of Lake Grace is committed to the implementation of water wise efficiency measures and, in installing the preferred synthetic green, will address the issue of excessive water use for irrigation and maintenance.

Varley Bowling Club received CSRFF funding in the 2007/08 round and replaced its grass greens with synthetic turf. The Lake Grace Sportsman's

Club application to CSRFF in 2008 to replace the grass greens with synthetic turf was unsuccessful. The Club has since funded the project with the assistance of a Shire loan. The number of existing synthetic turf projects in the Shire, one funded by CSRFF, may impact on the success of Newdegate Country Club's application.

#### Community Consultation

In planning the greens upgrade, Newdegate Bowling Club consulted Bowls WA, Lake Grace Bowling Club, various retailers of synthetic surfaces and Shire of Lake Grace staff.

Committee members from the Newdegate Bowling Club met with former Chief Executive Officer Jim Fraser on 17 April 2009, and with Development Officer Michelle Slarke on 7 September 2009 and again in September 2010.

Newdegate Machinery Field Days Committee and the Newdegate Community Cropping Committee have confirmed providing funding. Newdegate Primary School utilise the Bowling Green and has provided a letter of support for the project.

# Financial Implications

If successful, the additional expenditure of \$47,000 by the Shire represents a 20.6% increase on the specified area rate for Newdegate based on the rate raised in the 2010/2011 Budget.

# Summary

#### Background

A key element of emergency management planning is to ensure a co-ordinated response by all agencies having responsibilities and functions in an emergency.

An important principle of this planning is that local communities have control and coordination of emergency operations and the responsibility for preparedness, response and recovery. At a local level, the Lake Grace flood event in 2006 highlighted the need for an adequate Local Emergency Management Arrangement which is the subject of this report.

During the floods in 2006, the current Local Emergency Management Plan was found to be inadequate. After the floods funding was received from two sources to develop the new Emergency Risk Management Plans.

Since the adoption of the Emergency Management Act 2005, Fire and Emergency Services Authority (FESA) has become more involved with emergency management. Subsequently, it was found, that the plans don't follow FESA guidelines therefore it was necessary to rewrite the plans to become Local Emergency Management Arrangements.

The current Local Emergency Management Committee, local representative body, along with Mr Adam Smith, Community Emergency Management Officer FESA, worked together on the Local Emergency Management Arrangements that were then tabled and accepted, in its current form, at the Local Emergency Management Committee meeting held 19 August 2010.

#### Summary

The purpose of this report is to keep Council abreast of matters regarding the Lakes Voluntary Regional Organisation of Councils (Lakes VROC) that consists of the Shires of Lake Grace, Dumbleyung and Kent.

#### Background

The Wheatbelt Development Commission held a workshop with the Lakes VROC on 23 July 2010 in Dumbleyung to establish priorities for the region. The outcomes included:

- Aged, medium density housing;
- Solar or alternative energy generation project (three projects);
- Mobile phone towers with self correcting GPS.

As advised at the August Ordinary Meeting of Council, the Wheatbelt Development Commission invited the Shire Presidents and CEOs from all Wheatbelt local governments to a meeting on 8 September in Northam to look at the final list of projects for the region. A copy of the draft Wheatbelt Infrastructure Plan discussed at the Northam meeting was handed out to all elected members at the August Council meeting.

#### Comment

# Lakes VROC Meeting 7 September 2010

The Lakes VROC met at the Shire of Lake Grace to review the Draft Wheatbelt Infrastructure Plan and the priorities for the VROC including aged accommodation, renewable energy and mobile phone towers with self tracking signal capability.

The VROC agreed to look at the medium density housing project over at least two years as 2010/11 funding can now be carried forward. This would mean that 2010/11 and 2011/12 funding can be put to a significant project such as seniors accommodation.

At this stage the Wheatbelt Development Commission has suggested to build 20 units for the initial pilot project. The project would be in the order of \$5M and will require at least \$1.64M in funding from other sources.

The detail regarding the model in terms of the construction type, the number of units for each shire and who will manage the units has yet to be

determined. Each shire will need to make one hectare available. A two bedroom unit by National Lifestyle Villages fully fitted out will cost \$200,000 each.

The VROC will meet as required to review the scope of the project, meet with potential project providers and consider the business case.

The document from Cr Chamberlain on information from Landgate regarding self correcting GPS that can be accessed by local users was also put forward. The VROC resolved to invite Landgate to the next meeting to explain what Landgate is putting in place and how the shires can access this.

# Wheatbelt Infrastructure Plan Forum - Northam

The Shire President and author attended the Central Forum to finalise the Wheatbelt Infrastructure Plan. The forum was attended by over 100 people from across the 43 Wheatbelt shires, the Wheatbelt Development Commission, Regional Development Australia and private interests.

Minister Brendon Grylls and Parliamentary Secretary Wendy Duncan made it very clear that the Minister is looking for showcase regional projects. He appreciates how difficult it is to do the regional thing in the Wheatbelt, but because of our tenacity he is expecting a number of projects to come through that he can get in behind for further (financial?) support.

Minister Grylls in responses to questions on the GP issue made it very clear that it is not up to Local Government to take on the role of the Commonwealth and the State in this matter. Rather he said Local Government should turn things on its head. In particular look at the Commonwealth Government and the \$9.9b additional funding that has now been made available to Regional Australia through the Independents. Minister Grylls commented it is more about going to Canberra and saying we (Local Government) have funding under Royalties for Regions and will put this on the table and stating that now we have your interest, what will the Commonwealth do?

The Minister then went on to say he is over the stick approach and so now it is time for the carrot to be used. He acknowledged that local governments had been pushed from pillar to post regarding the Reform Process. However, he said we must think big. The ball is in our court. By way of demonstration the Minister cited the Peel VROC where a project has been approved that will not benefit one of its members (the Shire of Boddington).

The Parliamentary Secretary, made comment on maintaining of the local component of the Country Local Government Fund after 2013/14. She said that a good way to go would be to put a case to WALGA that could then be brought through to the Government. A suggestion is that this is set at the same percentage that has been allocated to the regional projects for 10/11 i.e. 35%. In the case of Lake Grace this would equate to no less than \$254,700 per annum. What is interesting to note is that the State's Forward

Estimates do show a 10% increase in the Country Local Government Fund each year. However, it was recently reported that there will be an additional \$2b additional paid in royalties to the State from this year onwards. Please note that this matter has now been put on the next Zone agenda.

Discussion was then had regarding what was a regional project. This was defined as something that has regional significance and involves local government collaboration. Regional significance was then defined as a project that was group wide and can either be:

- One asset e.g. research station; or
- A number of assets across the region e.g. aged housing.

The Shire President and author attended then attended the workshop on medium density housing with a focus on aged accommodation in the first instance. At this point there are 20 now projects listed for completion or progress across the Wheatbelt for 2010/11.

# **Regional Project Process**

Once the regional projects are confirmed, a business case is required including consultation with the respective communities. This must be completed by the end of December. Approval for projects and funding will be given once the business case is endorsed by the Department of Regional Development.

The template for the business case has now been issued for compilation.

# **Work Required**

A substantial amount of work will be required through the Lakes VROC to develop and deliver the regional projects. This needs to be taken into account regarding the other projects that the Shire of Lake Grace is seeking to deliver throughout 10/11 and 11/12.

The total allocation available to the Shire is \$727,715. The breakdown is as follows:

#### Funding Available to the Lakes VROC 10/11

The total funding that could be available to the Lakes VROC for 10/11 is \$669,495. However, the Shire of Kent will only allocate 50% of its funding thus reducing the total amount available to the VROC of \$570,420.

As such the Lakes VROC has agreed to do the aged accommodation project over two years. This means that there is the potential to put together a total cash contribution of approximately \$2.36M to the project over 10/11 and 11/12.

#### Summary

The purpose of this report is to update Council on the status of the Newdegate Research Station in regard to its use by the community. This includes the development of a positioning paper by the Shire's Chief Executive Officer as the first step in the possible development of a proposal that seeks a resolution regarding the future of the Newdegate Research Station.

#### Background

The author developed a positioning paper on the possible use of the Newdegate Research Station in response to the meeting scheduled with the Minister for Agriculture and Minister for Sport and Recreation (Member for Wagin) on 1 September 2010.

Mr John Morton met with the author on 27 August 2010 to see if he would attend the meeting with the Minister for Agriculture at the Newdegate Field Day to discuss the Research Station. As a result of the discussions with Mr Morton, the author developed a positioning paper that proposed the Newdegate Research Station being owned or managed by a community trust.

At the meeting on 1 September that was also attended by the Shire President, the author handed over a positioning paper to the Minister for Agriculture. In essence the positioning paper looks at the development of a proposal for the establishment of a community trust to take on the Newdegate Research Station.

In essence the positioning paper looks at how the community trust could develop a plan over the next three years on utilising the Research Station including:

- Continuation of community cropping and agricultural research;
- Alternative energy production and research;
- A temporary site for asylum refugees and others;
- Prison Work Camp;
- Making use of the water catchment.

The Minister indicated his agreement to consider a three year deal that would give the community groups a chance to set up the trust, develop a plan and seek the necessary funding to purchase the Research Station.

#### Comment

As Council would be aware the property in question is used for both community cropping and stock agistment. However, It is clear that there are a number of community groups within both Lake Grace and Newdegate who have been seeking a resolution regarding the future of the Newdegate Agricultural Research Station for some time.

The positioning paper points out that it is extremely important that when State Government Department infrastructure, holdings and/or service is to be withdrawn from a community that members of that community are given the opportunity to not only comment on the proposed change but to see if there is an opportunity to take on that infrastructure, holding or service.

The Lake Grace and Newdegate communities want the chance to do something with the Newdegate Research Station. The opportunities for a community trust in greater detail include:

- Continuation of the community cropping programs and thus an important source of income for both the Trust and the community cropping groups;
- The opportunity to continue and undertake agricultural research. The communities are passionate to have an opportunity to keep this alive and well. An example of such an approach is the Agricultural & Energy Resource Centre Inc. in the United States;
- Alternative energy and generation. The site in question is ideal in terms of the
  opportunities it can provide as a place for alternative power generation and
  research. This approach is being done successfully in the State of Victoria
  through Origin Energy;
- Alternative site for refugees and others who need to be housed until such times as their status is known. In simple terms, the site is available, so why not use it. This would require close cooperation between all spheres of government;
- Making the site available for a prison work camp or temporary accommodation. This is still a viable option considering that the State Government has a prison accommodation issue to sort out. It would not take much to get the Research Station to a point for use;
- It goes without saying that the site is a valuable water catchment for community use.

In simple terms, the Lake Grace and Newdegate communities should be given the opportunity to prepare a proposal and business case for why the Research Station should be handed over to the community. It is clear there is a mood for change in how business should be done with and by the Government. In other words there is a need to engage with communities in a more meaningful way including empowering them to determine their own destiny. Three years to develop a plan for action including the setting up of a trust, developing a business case and securing funding is not a tall ask of the State.

It was also raised with the Minister for Agriculture that the Shire is paying total lease payments of \$53,000 and this was considered excessive given that it is far in excess of the market rate. The Minister agreed to look at the arrangement in place.
